Orion Gold NL (ASX: ORN) announced on 16 April 2014 an offer to shareholders of shares under a share purchase plan ('SPP'). The SPP is underwritten by Orion's directors, Orion's major shareholder (Silja Investment Limited) and certain other underwriting parties who are "sophisticated investors" or "professional investors" for the purposes of section 708 of the Corporations Act ('Underwriters') to an aggregate amount of \$1.5 million.

The SPP offer closed on 16 May 2014.

The Company has today issued to SPP participants 10,699,972 fully paid ordinary shares in the Company at \$0.045 per share, raising \$481,499.

In accordance with the terms of the underwriting agreements, the Company has today issued to each Underwriter a notice specifying the number of shares required to be subscribed for and the amount to be paid by each Underwriter pursuant to their respective underwriting obligations. Certain of the Underwriters, including Orion directors and Orion's major shareholder, Silja Investment Limited are related parties of Orion and their commitments to subscribe for shares pursuant to their respective underwriting obligations (representing in aggregate \$700,000) are provided subject to Orion obtaining shareholder approval at a General Meeting to be held on 23 May 2014.

Please find attached an Appendix 3B relating to the issue of the shares resulting from a receipt of funds from SPP participants.
